Our upcoming LiveWell and WorkWell experiences in Delhi, Noida and Gurgaon are being built on the tenets of our operating philosophy with the wellness of our users at the forefront.

DELHI

Max Square Phase 2, in Okhla, New Delhi, is set to become a boutique campus, with two office buildings, and one residential block, and a total development potential of 0.5 million sq. ft.

NOIDA

Max Square Two in Sector 129, Noida, is being developed contiguous to the fully completed, Max Square, Max Estates' third commercial development. The total development potential of the ~6.5 acre campus is ~1.5 to 2.0 Mn sq. ft., which will not only provide prospective tenants of Max Square an option to expand, but also enable access to an integrated mixed-use campus that will be unique to the metro market.

GURGAON

We entered the Gurgaon Commercial Real Estate (CRE) Market with the acquisition of a ~705-acre land parcel right on Golf Course Extension Road (GCLR) which has a development potential of ~16 mn sq. ft. It is one of the very few commercial land parcels available on GCLR with these characteristics. Gensler, a leading global design and architect firm is designing the office ecosystem, which will bring Max Estates' WorkWell promise to Gurgaon.

The Jogger, installed at Max Square, is created by Guy Du Toit. A part of the artist's famous series called *Lanes*, the larger-than-life 12-foot artwork symbolizes life, resirth, and energy, and is an ode to the nature theme of the building which unites nature with work, with a 10,000 sq ft central forest courtyard in its midst. The Jogger is made entirely of bronze, a dynamic material, that transforms from black, to brown, to green as it interacts with the elements of nature. The statue-like sculpture will eventually morph into a natural green, a beautiful allegory for the ever-changing nature of life, urging us to embrace transformation and transitions in our own personal and professional lives.

Guided by the vision of caring for life, with its inception, MIF has provided quality, affordable and accessible healthcare to make a difference to the lives of the underprivileged community in India.


